# New Rules Benefit FSS Participants

It is not too late to take advantage of the new FSS program rules! Some of the rule changes are:

- Contract expiration dates will extend to 5 years from the date of the first recertification of income after the start date of the contract. This means participants will be able to stay on the program longer and potentially earn more escrow!
- Participants will no longer need to be free of cash assistance for 12 months prior to graduation. Now participants will only need to be free of cash assistance at the time of graduation.
- Monthly escrow credits can continue to grow if a family is between 50% and 80% of the area median income. This means participants may be able to earn a higher amount of escrow.
- The definition of "good cause" for a contract extension is broader. Participants may be able to extend their contract if they need more time to complete a goal.

If you would like to participate in FSS under the new rules, you just need to sign an updated contract of participation. It is that easy!

## **SECTION 8 GOES PAPERLESS**

SEMMCHRA is pleased to announce that the Housing Choice Voucher Program (Section 8) has gone paperless and now has a secure resident portal system where participants can access at their convenience 24/7.

**Effectively immediately**, Section 8 will now be sending all correspondence and rent statements through email and the resident portal.

Voucher participants now can submit income and family changes using our "report a change button" on the online portal.
