2023 Annual Report

Goodhue County strives to effectively promote the safety, health, and well-being of its residents. In 2018, in an effort to provide housing stability for its residents at all income levels and stages of life, Goodhue County established the SEMMCHRA Goodhue County Affordable Housing Trust Fund (AHTF) dedicated to preserving and creating affordable housing opportunities for households with lower incomes. As outlined in the Purpose and Intent of the Housing Trust Fund, it states,

"This fund shall include a preference for the creation of Workforce and Elderly Housing units, which shall include moderate, low, and very low-income households. The Trust Fund shall be a permanent endowment and continually renewable source of revenue to meet, in part, the housing needs of Moderate, Low Income and Very Low Income households of the County. The Trust Fund is to provide loans and grants to homeowners, and for-profit and non-profit housing developers for the acquisition, rehabilitation, emergency housing, capital and soft costs necessary for the creation of new Affordable rental and owner-occupied housing. Preference shall also be given to those projects that ensure that the Assisted Units remain Affordable for the longest period possible. Projects funded by the Trust Fund shall be disbursed

throughout the County so no single area experiences a disproportionate concentration of housing units for Low Income and Very Low Income households."

What is an Affordable Housing Trust?

A Trust Fund is a tool established under Minnesota State Statute 462C16 cities and counties can use to rehabilitate and preserve existing affordable housing, develop new affordable housing, and provide rental and down payment assistance.



In 2023:

2023 Funding for the Trust Fund was provided through the Goodhue County tax levy totaling \$100,000 to further the opportunities to support affordable housing in three primary categories including:

- -Workforce Housing Assistance through Downpayment and Closing Cost Assistance.
- -Multi-Family Project Funds for new or existing housing developments.
- -Flex Funds to address local housing needs as they arise. Program example: Rural Rehab Loan Program.

Efforts began in 2023 to "Bring Home" State housing funds by leveraging local housing trust fund dollars. Watch for news releases or contact SEMMCHRA to learn more.


HOUSEHOLDS SERVED: 4 (2023)

Sixty thousand dollars (\$60,000) was provided to four income eligible households, that purchased homes, each receiving fifteen thousand dollars (\$15,000). Program to date: 9 households served.

One hundred percent (100%) were households with children. Seventy-five percent (75%) were households renting/living in Goodhue County and twenty-five percent (25%)

were households that moved into Goodhue County.

One (1) household was at or below eighty percent (80%) AMI, while three (3) other households were above eighty percent (80%) AMI. All of the unit types were single family
